Historian Yuval Noah Harari is a Big Thinker. His 2024 blockbuster book, Nexus: A Brief History of Information Networks From the Stone Age to AI, concerns how Artificial Intelligence will shape our future. An AI "app" is a computer program trained on a vast amount of information (from the internet), learning to see patterns, for use in carrying out tasks. This is not thinking as we humans think of thinking; that's probably a long way

off. Nevertheless, AI has huge impacts on many aspects of our lives, which Harari's book magisterially explores. A key problem is AI acting as an "alien" intelligence — working along lines we may not even understand. The book also importantly explores its implications for the future of democratic versus totalitarian systems.

Frank S. Robinson is a graduate of NYU Law School (1970), and served at the New York Public Service Commission as staff counsel and then administrative law judge (1977-97). He is the author of eight books including <u>Albany's O'Connell Machine</u> (1973), <u>Children of the Dragon</u> (a novel), <u>The Case for Rational</u> <u>Optimism</u> (2009), and <u>Love Poems</u>. Robinson is a professional coin dealer. He is married to the poet Thérèse Broderick and has a daughter, Elizabeth. Robinson was appointed to the U.S. Assay Commission by President Nixon in 1972.

# On Sunday, April 13th, 2025, 12:30 PM (In Person) and 1:00 PM (Online) The Capital District Humanist Society Presents: **Reading the Rock Record: Understanding Our Future**

It's difficult to understand how one or two degrees of global temperature rise can even be observed, much less have any impact on climate and ecosystems. It's especially difficult to accept as we struggle through another cold and snowy winter. The effects of global warming are hardly noticeable on the timescale of a person's life. However, on a geologic time scale, abrupt climate change and its catastrophic effects are readily discerned. We'll discuss how we use 19th, 20th, and 21st century techniques to tease information about climate and environment from rocks and how we can correlate this

with events in the fossil record. We'll put special focus on an event called the Middle Eocene Climatic Optimum (MECO), a period of global warming that occurred around 40 million years ago and is recorded in rocks of western Utah.

Penny Higgins is a consulting geochemist and paleontologist with her business, EPOCH Isotopes. Her specialty is using chemical studies of rocks and fossils to infer patterns of temperature, precipitation, vegetation, and dietary preferences. She applies her technical and instrumental knowledge as the Laboratory Operations Supervisor at Eastman Kodak Company in Rochester, NY. Though she loves science, she loves her cats more and founded Mew-Mew House, a 501(c)3 retirement and hospice home for cats, which she runs out of her house.

## **RECAP OF OUR FEBRUARY SPEAKER'S TALK**

Dr. Mark Reimers is a quantitative neuroscientist at Michigan State University. His topic was "The Social Psychology of Group Delusions."

He defined a "delusion" as a belief or impression firmly maintained despite being contradicted by what is generally accepted as reality or rational argument. This has usually been associated with disordered thinking — psychosis or mental illness.

Yet most people are deluded about some things, at some times. A good example is when one is "madly in love," a fairly common phenomenon. Reimers noted that the brain activity there has been found to resemble that in the brains of addicts.

But he also discussed what he called "everyday delusions." A basic one is self-importance. Most people believe they are above average (mathematically impossible). Such beliefs help us navigate through life. False memories are a part of it — we love to tell stories, and to embellish them, making ourselves more central, and our memories are actually continually rejiggered to comport with that.

Another topic was "dogmatic thinking," with the key factor being not the content of a belief, but how one believes it. Dr. Reimers referenced an impatient cognitive style — jumping to conclusions, unwilling to consider nuance. And such cognitive and personality traits govern the likelihood of adopting an ideology, like QAnon.

Key indicators there include bold, sweeping language; considering other people not just wrong, but bad; insulting them. There's a heavy use of abstract moral nouns like "necessity" and "freedom."


Important in all this is not so much the validity of the beliefs, but rather keeping in good stead with your group. This is especially true with religion — also helping us deal with what some might see as the meaninglessness of existence, countered by imagining there's a God who loves us.

The social element is particularly important given how many people feel anxiety about their social connections. Feeling isolation, resentment, humiliation, and economic stress, all amplified socially. And, Dr. Reimers noted, that such stress it elf alters our cognition style.

He opined that this is increasingly salient in America, with hollowed out opportunity for working class people who can't think clearly about their life situation. There's a breakdown in shared societal consensus. And while modern society disperses us, social media creates the equivalent of the mob.

So — how can we combat all this? Dr. Reimers pointed to two persuasion techniques that have been developed, which seem to have some success in changing at least some minds. "Street epistemology" employs the Socratic Method, starting by asking people, for example, how confident they are in their beliefs. "Deep canvassing" begins by trying to connect with people as individuals, following up on concerns they express.

## Oregon Democrat's bill cracks down on Christian "health care cost sharing" ministries

Faith-based "health share" companies have left many families in medical debt. Rep. Bob Nosse wants more transparency in the system. by Hemant Mehta on Substack • 24 February 2025

An Oregon lawmaker has introduced a bill designed to crack down on Christian "health care cost sharing" companies that have scammed upwards of 1.5 million people across the country. House Bill 2268, introduced by State Rep. Rob Nosse, would require such companies to disclose basic information about what services they provide (and don't provide), forbid them from claiming they're actual "health insurance" companies (because they're not), and force them to disclose how much money they've collected and paid out.

In short, the bill would provide customers with better information so they know what they're buying into, allowing them to hold Health Care Sharing Ministries (HCSMs) accountable if they fail to deliver on their promises.

Before diving into the specifics of this bill, it's important to understand what we're even talking about. In 2022, Christianity Today found that Sharity Ministries (formerly Trinity HealthShare), which filed for bankruptcy in 2021, left 10,000+ families with unpaid bills totaling over \$50 million. That's just one company. There are several others just like it.

## What are Health Care Sharing Ministries?

While every company operates a little differently, HCSMs like Samaritan Ministries and Liberty HealthShare ask everyone in the system to pay a specific

amount into the insurance pool every month... and if you ever need something covered, you make a request and the company will send a certain amount of money to you or your provider.

That's not really different from regular insurance, but these companies are not regulated, refuse to cover certain services, and can cut you off at anytime if you become too expensive to insure. Even worse: If you do something they deem "immoral," you may not get any moneyat all. (HCSMs generally do not cover contraception, extend care to your same-sex partner, and refuse to assist with abortion care.)

So everything is fine... until the moment you need them the most. Many participants don't realize that until it's too late. They also don't realize how badly they can get screwed over. California once sued an HCSM, claiming that it "routinely denied claims and spent just 16 cents of every dollar in premiums on health care expenses." By contrast, the Affordable Care Act requires (legitimate) health insurance companies to spend at least 80 cents of every dollar on expenses.

There have been numerous articles written over the years about customers who were denied help precisely when they expected toreceive it. The end result is that Christian insurance companies are just like Christian movies and Christian theme parks: They claimto offer suitable alternatives for secular services... but they're so much worse than the real things.

## What the Oregon bill would do

The new legislation proposed by Rep. Nosse would try to prevent the worst case scenarios from taking place by doing four thirgs in particular:

1. Require HCSM sellers to register with the state. Anyone who offers or sells HCSMs would have to register with Oregon's Department of Consumer and Business Services.

2. Require HCSMs to be transparent about coverage. The companies would have to file an annual report saying how many enrolles they have, how much money those clients pay them, and how much money the company pays out as claims.

3. Forbid HCSMs from calling themselves "health insurance." That means no advertising or marketing suggesting they're legitimate insurance providers.

4. Require HCSMs to disclose which medical services they will not cover. That includes reproductive care, HIV/AIDS medication, and genderaffirming care.

None of that would stop HCSMs from existing. None of that would interfere with their faith. This is about consumer protection, not religious oppression. It's about transparency, not censorship.

The Center for Freethought Equality, the advocacy arm of the American Humanist Association, has praised the bill and is calling on Oregon lawmakers to pass it:

"The Center for Freethought Equality is proud to partner with Rep. Nosse to bring greater transparency to these questionableorganizations masquerading as insurers. We stand ready to help Oregon pass this legislation to protect the well-being of its residents," said Fish Stark, Executive Director of the Center for Freethought Equality. "Oregon can send a clear message to these health care cost sharing organizations, who often hide behind the pretense of religion, that denying vulnerable people health care coverage and defrauding them when they need it the most is unacceptable."

Leave it to an organization representing non-religious Americans to promote legislation meant to keep Christians honest because those Christians can't do it themselves.

For now, the bill is in the hands of the House Committee On Behavioral Health and Health Care.

Now is the time to get involved and make sure our lawmakers protect our country's democratic principles and represent all ofus—no matter how they or we identify religiously.

#### WHAT YOU CAN DO:


Only buy essentials of absolutely necessary (Food, Medicine, Emergency Supplies) If you must spend, ONLY support small, local businesses.
